In addition, a new equipment management plan will be needed this year.

Discussion followed with suggestions to work out:

- how to handle the equipment allocation differently, such as signing out wetsuit and basic gear for the summer. Mike offered to create a sign out form.
- having a gear try on weekend at the Jorge residence for members without their own gear,
- how to transport of tanks, regs and BCDs to the dives,
- how to organize a car pool, possibly using the club's Whatsapp chat,
- requiring dive sign ups 2 weeks in advance in order to accommodate the additional organization tasks
